The TCBA board was unable to consider Sue's request based upon statutory provisions for a 501 (c) (4) organization. As a nonprofit 501 (c) (4) organization the TCBA must operate exclusively for the promotion of social welfare or operate primarily to further the common good and general welfare of the people of the community. The exemption from federal income tax under section 501 (c) (4) states the TCBA's net earnings must be devoted only to charitable, educational, or recreational purposes. No part of the TCBA's net earnings can benefit any private shareholder or individual. Board Member Engelen will contact Sue Rugaard and Cindy (Wegner) Luczycki.
